Spray Marking: Suitable for use with both liquid and powder herbicide products and can be used to help identify sprayed areas. Foam Marker Dve: Where a coloured foam is required for foam markers, add at the recommended rate to dilute foam inixture. RATE OF APPLICATION

MIXING INSTRUCTIONS Important Note: When using in conjunction with Amine based products such as Weed Force A-Mine 625 Broadleaf Herbicide, 2,4-D Amine 500 and MCPA 500, ensure that WEED FORCE RHODAMINE RED MARKER DYE is thoroughly mixed with the water before adding any herbicide. Then slowly add the herbicide whilst the spray tank is being agitated. Thoroughly clean out tank and equipment after each use. If product residue is left in equipment colouration of subsequent sprays can be expected. PROTECTION OF WILDLIFE.
